*The SRMH team wishes to commemorate the life of Francois Landu, the Monitoring and Evaluation officer and also the Training and Capacity Development Manager for the SAFPAC Initiative in Chad. It is with deep sadness that we relate his untimely passing. Francois died on February 24, 2015 on duty, in a vehicle accident while traveling to visit a field site.*

*Francois had joined the SAFPAC team early in the project in 2011 and had served first as Social Communication officer then as Sexual Reproductive Health Coordinator in Gore, Logone Oriental Region southern Chad, before leading SAFPAC-Chad's training efforts, monitoring and evaluation.*

*Francois was a dedicated and tenacious leader, devoting energy and talent above and beyond the call of duty to our shared goals of improving the lives of women, girls and communities not only in Chad programs, but also in Djibouti.*

*Originally from the Democratic Republic of Congo, Francois lost his wife, Grace two years ago by a brain cancer and he is survived by his two children, Parousia, 10 and Elschadai, 12 still of the DRC.*



## SRMH Global Updates

### **CARE Bangladesh participates as panelist in a Woodrow Wilson Center Dialogue event**

On March 31<sup>st</sup>, Dr. Jahangir Hossain of CARE Bangladesh participated as a panelist at a Woodrow Wilson Dialogue event, “South Asia Consultation on Maternal Health: Regional Dialogue and Way Forward,” in Washington, DC. In early February, Dr. Jahangir attended a two-day, regional workshop on maternal health hosted by Oxfam India. The Woodrow Wilson event continued the discussion from this consultation about how best to improve maternal health results in South Asia. As a panelist, Dr. Jahangir also described a CARE, GlaxoSmithKline funded, innovative public-private partnership model, using skilled, private, maternal, and child health providers to reach remote and marginalized communities in Bangladesh. The event was attended by USAID and organizations such as Abt Associates, IntraHealth and Johns Hopkins University, among others. The event was [webcast](#) live.

### **Partnership between CARE USA, University of North Carolina and CARE Malawi + Film Screening**

Twenty-three University of North Carolina (UNC) journalism students and four coaches traveled to Malawi in early March to work with ten University of Malawi (UM) Journalism students to document how the [Community Score Card](#) empowers community members, health workers, and the local government to address the persistent barriers women face in accessing high quality health services. The UNC class will produce videos, infographics and written pieces for a documentary site to be published by CARE this summer—multiplying sexual, reproductive, and maternal health impact! The films created by the UNC and University of Malawi journalism students will be screened in Chapel Hill, North Carolina, USA, on May 1<sup>st</sup>. The event will begin at 5pm with a reception, followed by a screening of the documentary film series and a panel discussion with CARE and UNC School of Journalism faculty and students. ### **Editorial and two CARE articles in *Global Health Science and Practice* highlights SAFPAC work**

The March issue of *Global Health Science and Practice* includes an editorial highlighting the Supporting Access to Family Planning and Post-abortion Care (SAFPAC) team’s recent publications (Curry et al.). The editorial, “Stunning Popularity of LARCs With Good Access and Quality: A Major Opportunity to Meet Family Planning Needs” positively highlights the success of the SAFPAC work and reiterates the idea that an optimal method mix can “prevent

### **GlaxoSmithKline-CARE Initiative Partners Meeting discusses work in 6 CARE Countries**

In March, GSK and CARE held a partners meeting in Cambodia to discuss current programs and the way forward for GSK in CARE countries. The GSK-CARE partnership is unique, as GSK is reinvesting 20% of its profits into the least developed countries in which it makes profit. GSK is partnering with NGOs to provide guidance on how best to reinvest the 20%. CARE is GSK’s Asia partner, working in Bangladesh, Nepal, Cambodia, Laos, Myanmar and Afghanistan, and managed by CIUK. Among other things, participants discussed where CARE is going as a global organization and how the GSK initiative fits in and contributes to the goal of reaching 100 million women and girls through programming, learning and sharing. GSK is very interested in building country-based advocacy components into the next set of proposals, and building the visibility of the partnership and the innovative models it is generating, with the goal of “multiplying impact” in the countries and beyond.

### **CARE investing in advocacy to help shape the UN Global Strategy for Women, Girls and Adolescent Health**

In tandem with the development of the new set of Sustainable Development Goals (SDG), there is now a multi-stakeholder effort underway to develop the [UN Global Strategy for Women, Girls and Adolescent Health](#). The strategy will be the definitive policy guide for implementation of the new SDG targets related to sexual, reproductive, maternal, child and adolescent health; the technical strategy (Sept 2015) and implementation plan (May 2016) will be developed over the next 1.5 years. Christina Wegs from the CARE USA SRMH team is serving as one of four civil society representatives on the Accountability Work stream of the Global Strategy, which will shape accountability systems for the Global Strategy at global, national and sub-national levels. CARE is contributing to joint advocacy through the Respectful Maternity Care Alliance and the Interagency Working Group for Reproductive Health in Emergencies (IAWG), as well as providing ongoing feedback on pillars of the strategy related to women's health, adolescent health, human rights and SRMHR in humanitarian contexts. ### **Women's Refugee Commission honors Adey Ali Dahir of CARE's Kenya Refugee Assistance Programme**

Adey Ali Dahir, popularly known as Mama Adey, has tirelessly worked for decades to ensure that Dagahaley Camp, one of the five Dadaab Refugee Camps in Kenya, is a safe haven for Somali women and girls. She is a member of CARE Kenya's Refugee Assistance Programme's "Committee against Violence," a community-based support group. Mama Adey, now 70 years old, has worked since 1992 to end sexual and gender based violence, child marriages and female genital mutilation. Mama Adey is being honored at the Women's Refugee Commission luncheon on April 30, 2015 in New York.



### **CARE participates in UN- Post 2015 Accountability event in Peru**

CARE UK participated in “Dialogue on the Implementation of the Post-2015 Development Agenda: Participatory Monitoring for Accountability,” hosted by the UN in Lima, Peru March 12-13th. The global event brought together experts, practitioners and policymakers to share results, good practices and lessons learned in Participatory Monitoring and Accountability (PMA). CARE represented its social accountability and participatory monitoring work. The event formulated recommendations for a way forward in PMA within the Post- 2015 framework (especially in relation to the SDG 17, which highlights the need to take urgent steps to improve the quality, coverage and availability of disaggregated data to ensure that no one is left behind.)

### **Published Article: Community-to-Community Learning Strategy by CARE India**

CARE India colleagues (Santhosh Sadhu, Archana Rao Manukonda, and Anthony Reddy Yeruva) published an article in PLOS ONE journal “[Role of a Community-to-Community Learning Strategy in the Institutionalization of Community Mobilization among Female Sex Workers in India.](#)” The article aims to understand the role of the community-to-community learning strategy in the institutionalization of community mobilization among sex worker communities across eight districts of Andhra Pradesh, India.

### **CREA's Sexuality, Gender and Rights Institute—Istanbul, 21-29 June 2015: Deadline 30 April 2015**

CREA's 9<sup>th</sup> Sexuality, Gender, and Rights Institute: Exploring Theory and Practice. The course will be held 21 - 29 June 2015 in Istanbul, Turkey. CREA's Sexuality, Gender, and Rights Institute is an annual residential course -- begun in 2007 -- which focuses on a conceptual study of sexuality and its application to programme interventions. The Institute examines the links between sexuality, rights, gender, and health, and their interface with socio-cultural and legal issues. Participants critically analyse policy, research, and program interventions using a rights-based approach. Registration and Course fees are due on or before 25 May 2015. Registration fee: USD 150. All selected applicants will have to pay this fee. Course fee: USD 2800. This covers tuition, resource package, accommodation on a twin-sharing basis from 19-28 June 2015 (9 nights), and all breakfasts. Please note that this is a subsidised cost for participation. The expenses per participant total approximately USD 4500. Not included in the course fees: Travel costs and lunches/dinners. The June Implementing Best Practices (IBP) Semiannual Meeting offers a unique capacity building opportunity for our FP/RH colleagues in the region. Bringing together local implementers and decision-makers, the meeting will build upon the experiences and insights from the East Africa region, identifying opportunities to leverage and challenges to learn from as we work to advance implementation and scale-up of effective practices in the region's unique contexts. The June Semiannual Meeting will showcase the work of IBP (of which CARE is a member) and the variety of practical tools and support mechanisms that the initiative offers to assist local actors in FP/RH implementation and program management. The meeting will include presentations from the IBP community regarding lessons from implementation and scale-up of effective FP/RH practices in the region, providing a targeted look at the experiences of Ethiopia and bringing key insights from other countries in the region. This year, the June meeting will also include site visits in Addis Ababa, allowing meeting participants' hands-on and participatory engagement with examples of high impact practices in local implementation.

**Jesse Rattan** has been promoted to Director, Sexual, Reproductive Health in Emergencies (SRHE) Global Program. In this new role, she will work with colleagues from across the



organization to support integration of SRH across the humanitarian-to-development continuum, and to support learning, program quality and multiplying impact, as we work to advance the [CARE 2020 Program Strategy](#).

Jesse earned her undergraduate degree in English from Vassar College, her nursing degree from Johns Hopkins University, and her MPH from the University of California, Berkeley. She was a Peace Corps Volunteer in the Central African Republic and has worked in Haiti, Kosovo and East Timor. Adding to this diverse educational background and experience, during her almost 15 years at CARE, she has worked as the Health Sector coordinator in Cambodia, a proposal development coordinator in the Competitive Bids Unit, and most recently as a Senior Technical Advisor for Mothers Matter, and then Project Director for the SAFPAC initiative on the SRMH team, and as the global focal point for SRHE.

As head of the Supporting Access to Family Planning and Post-abortion Care (SAFPAC) initiative, she has led the design and implementation of a 27.5 million dollar reproductive health program in five crisis-affected countries—Chad, DRC, Pakistan, Mali and Djibouti. In this role, she manages a team of 5 US-based employees, and works closely with field-based project managers, senior country office leadership, government and non-governmental partners. After the first phase of the initiative, she successfully secured funding for another 3 years (Phase 2), and is now looking forward to an even larger scope for Phase 3. She also recently oversaw the [publication](#) of two major papers from the SAFPAC initiative on CARE’s success in increasing access to and use of long-acting methods of contraception in crisis-affected settings—the results were referred to as “stunning” in an editorial that accompanied the publications.
